OPEN LEARNING

Plus video/photo evidence

The open learning programme is designed to allow the participant to work at their own pace in their own home or business. Participants receive the current Spray Solutions Reference Manual which they may keep for future reference.

Participants must complete and submit:

- > Student Declaration
- > Theory assessment
- > Practical tasks demonstrations recorded on video and photos

Instructions on providing evidence will be included in your Spray Solutions Chemical Accreditation pack.

HALF DAY WORKSHOP

Plus open learning theory

A combination of a half day workshop and open learning theory. This method is designed to allow a group of 10 or more participants to meet at a local venue with our assessor who will complete some practical assessments on the day. Participants will be issued the Spray Solutions Reference Manual and theory assessment to take home and complete in their own time.

Participants must complete and submit:

- > Student declaration
- > Theory assessment
- > Practical assessments are completed at the workshop

TWO DAY WORKSHOP

For inexperienced operators

Participants must be enrolled with RST in a full qualification either as a trainee, school student or Ticketing and Licencing program.

The two day workshop comprises all training and assessment required.
