TOPICS

Students enrolled in the course are required to complete the core units of competency below to complete their qualification:

- > AHCWHS302 **Contribute to workplace health and safety processes**
- > AHCWRK320 **Apply environmentally sustainable work practices**

In addition if you study the AHC32822 Certificate III in Rural Operations, you will also need to complete

- > AHCBIO303 **Apply biosecurity measures**

ELECTIVE TOPICS

During the enrolment process, RST staff will work with students to develop a tailored training plan. Elective topics that can be undertaken include:

MACHINERY MAINTENANCE

Basic machinery maintenance and care of machines and engines, including small motors such as irrigation pumps.

SOIL SAMPLING AND TESTING

Skilled growers of quality food understand the physical and chemical properties of the soil and know how deficiencies and toxicities can be managed. The foundation of this capability is to undertake correct sampling and testing of soil or growing media, including collecting soil or media samples, performing basic tests on soil or media samples, and completing sampling and testing activities.

PEST CONTROL TECHNIQUES

Gain an understanding of the various pest control techniques that may be appropriate to vegetable growers. Giving consideration to minimising chemical applications identify pest control techniques to incorporate longer term and strategic

approaches to pest management.

BIOSECURITY

Interpreting and applying control measures in a biosecurity plan to protect sites from the entry and spread of biosecurity threats.

CHEMICAL ACCREDITATION

Gain full chemical accreditation to purchase and use S7 chemicals.

CROP AGRONOMY/PEST, DISEASE AND WEED CONTROL

Identifying the requirements, deficiencies or problems in vegetable crops and treating such problems to meet Maximum Residue Level tests, withholding periods and to avoid resistance issues.

INTEGRATED PEST MANAGEMENT (IPM)

Learn the benefits of IPM and how it can be embedded into a growing region. What are beneficial insects. How are they bred, fed and released, then monitored. Maintain a breeding and release station. Assess the benefits and challenges of growing vegetables using IPM.

TROUBLESHOOTING AN IRRIGATION SYSTEM

Checking for faults, maintaining the system, ensuring plants are getting the correct amount of water at the correct times.

FUNDING AND ELIGIBILITY INFORMATION – WORKREADY

If you are looking to do a traineeship under a Training Contract, RST can put you in touch with an apprenticeship network provider consultant who can advise on eligibility and arrange the paperwork for your Training Contract.

FREQUENTLY ASKED QUESTIONS

WHERE WILL THE TRAINING BE HELD?

Most of the training will take place at your farm. Some classroom training will be held at RST's purpose built training facility at Beverley.

WHEN CAN I START?

You can enrol and commence your training at any time.

HOW LONG DOES THE COURSE TAKE?

By attending all scheduled workshops and successfully completing all assessments, a course should take between 18 months and two years to complete.

WILL I NEED TO COMPLETE ASSESSMENTS?

The assessment methods vary between topics. You will need to demonstrate the knowledge and skills learnt throughout the course by conversations with RST staff, workplace demonstrations and supplying photo and video evidence.

- > Every student has access to RST's Agronomists, On Farm Support team and Administration Support team.
- > During your enrolment we will visit you on farm on a regular basis to provide support and help you become a better grower.
- > RST's On Farm Support team speak English and Vietnamese
- > RST will provide you with Training and Freshcare documents in English or Vietnamese.

STUDENT SUITABILITY AND SUPPORT NEEDS

As per government funding and training standards, RST is required to determine the support needs for students. As such, RST requires all students to complete an Upfront Assessment of Needs process (UAN).

A suitability and support needs checklist will be completed as part of the enrolment process. Students will need to complete a Language, Literacy and Numeracy Assessment. Where language, literacy and numeracy barriers are identified. RST will work with you to put an appropriate support plan in place.

DO I NEED ACCESS TO ANY SPECIFIC EQUIPMENT TO COMPLETE THIS COURSE?

Students need to wear work boots and appropriate work wear for practical workshops and have access to the internet, a laptop or tablet and a smart phone.
